Relating to Human Resources, the Interim Organizational Review identified recommendations for:

- A. Two new Program Supervisor positions to provide direct/on-shift supervision of all programs, especially during evenings and weekends. The Program Supervisors would relieve the reporting burden on the Program Manager, and will need to be hired as soon as possible as the Program Manager will be going on Parental Leave at the end of February 2009.
- B. A new position in the Resource Development and Communications department (exact title still to be confirmed position description is with City Compensation) that will coordinate all donor stewardship responsibilities, invoicing, research, tax receipting, reports, and design/web content management.

Maura then presented the 2009 Self-Sustaining Budget, which included the three positions identified in the Interim Organizational Review. Additional cost pressures in 2009 will also mean that the Centre will run a deficit in 2009.
